### **MINUTES OF PROCEEDINGS**

#### 1. Monday 25 November 2002

The sitting was opened in public at 9.30 am in the Worsley Suite, Worsley Park Hotel and Country Club, Manchester, with Mr David Winnick MP in the Chair.

The Chairman announced that, pursuant to Rule 2(a), Mr Kevin Brennan MP, Mr Jeff Ennis MP, Mr Dominic Grieve MP, Mr John Robertson MP, Gareth Thomas MP, Ms Shona Robison MSP and Mr Jamie Stone MSP, being Associate Members, had accepted the invitation of the Steering Committee to assume the powers and responsibilities of Members for all of the Session.

#### ADOPTION OF PROPOSED PROGRAMME OF BUSINESS

*Ordered*, That the proposed Programme of Business for the current Session, as amended, be approved.—(*Mr Brendan Smith*.)

#### RECENT POLITICAL DEVELOPMENTS

Motion made and Question proposed, That the Body reaffirms its support for the Good Friday Agreement; is saddened at the suspension of the devolved institutions in Northern Ireland; welcomes the determination of the two Governments to press ahead with all aspects of the Agreement, calls on all political parties to redouble their efforts towards the restoration of the institutions which have benefited all the people of these islands; and urges all involved parties to continue their efforts to secure an early resumption of the Northern Ireland institutions — (**Mr Jim O'Keefe**);
