## 1. Monday 18 October 2004

**The sitting was opened in public at 9.30 am in the St Pierre Suite, St Pierre Hotel, Chepstow, with Mr David Winnick, MP, in the Chair**

**The Chairman** announced that, following a reshuffle of the Irish Government, his former Co-Chair, Mr Brendan Smith, TD, Mr Tony Killeen, TD, and Mr Conor Lenihan, TD, had been made ministers. As a consequence, Mr Seamus Kirk TD would act as his Co-Chair for the session. He read a letter from Mr Smith wishing the Body well in its deliberations.

The Body **agreed** to send its congratulations to the former Members concerned, and also to Mr Alex Salmond, MSP, who had once more become Leader of his party.

**The Chairman** announced that, pursuant to Rule 2(a), from Ireland Senator Paul Bradford, Senator Paul Coghlan, Senator Geraldine Feeney, Mr Ned O'Keeffe, TD, Senator Mary White and Senator Diarmuid Wilson, from the United Kingdom Mr Dominic Grieve, MP, Baroness Harris of Richmond, Andy King, MP, and Mr Gareth Thomas, MP, from Scotland Mr Bruce Crawford, MSP, Ms Helen Eadie, MSP and Mr Michael McMahon, MSP, from the States of Guernsey Senator Maurice Dubras, being Associate Members had accepted the invitation of the Steering Committee to assume the powers and responsibilities of Members for all of the session. Pursuant to the provisions of the same rule, Deputy Graham Guille, Associate Member from the States of Jersey, would attend in addition to the nominated Member.
